ANNOUNCEMENT POWER GENERATION FOR SEPTEMBER 2025

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the "Company") for September 2025 on a consolidated basis amounted to 5,292,152 MWh, representing a year-on-year decrease of 5.35% as compared with the corresponding period of 2024, excluding the impact of coal power, representing a year-on-year decrease of 0.50%. During the month, the wind power generation registered a year-on-year decrease of 12.47%, and PV power generation registered a year-on-year increase of 85.51%.

As of 30 September 2025, the total power generation of the Company for 2025 amounted to 56,546,706 MWh, representing a year-on-year decrease of 0.53% as compared with the corresponding period of 2024, excluding the impact of coal power, representing a year-on-year increase of 13.81%, in particular, the wind power registered a year-on-year increase of 5.30%, and PV power registered a year-on-year increase of 77.98%.
