ANNOUNCEMENT COMPLETION OF ISSUANCE OF ULTRA SHORT-TERM DEBENTURES

This announcement is made by China Longyuan Power Group Corporation Limited* (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 17 June 2025 on the poll results of the 2024 annual general meeting of the Company in relation to the approval of the issuance of debt financing instruments by the shareholders of the Company.

The Company has completed the issuance of ultra short-term debentures (the “**Ultra Short-term Debentures**”) of the Company on 26 January 2026. The aggregate issuance amount of the Ultra Short-term Debentures was RMB2.0 billion with a term of 267 days, nominal value per unit of RMB100 and coupon rate of 1.55%. The interest shall be accrued from 27 January 2026.

China Bohai Bank Co., Ltd. was the lead underwriter and China Minsheng Bank Corp., Ltd. was the joint lead underwriter for the public offering of the Ultra Short-term Debentures. All proceeds raised from the Ultra Short-term Debentures will be used to replenish daily working capital and repay the interest-bearing debt of the issuer and its subsidiaries.

This announcement does not constitute, or form part of, an offer or invitation, or solicitation or inducement of an offer, to subscribe for or purchase any of short-term debentures or other securities of the Company, nor is this announcement distributed to invite offers for any securities of the Company.
